


GROUNDS OF ARREST

To

This is to inform you that you are being arrested in connection with CBI FIR No. RC2212026E0010 dated 12.05.2026 registered at CBI, EO-III, New Delhi for offences punishable Under sections 61(2), 238, 303(2), 316(5), 318(4) of BNS, 2023, section 13(2) r/w 13(1)(a) of PC Act, 1988 (as amended in 2018) and section 10 r/w 3, 4, 5 & section 11 of The Public Examinations (Preventive of unfair means) Act, 2024. The grounds of your arrest are mentioned below.


Grounds of arrest

That investigation has revealed that Sh. Shivraj Raghunath Motegoankar is an active member of the organized gang involved in the leakage and circulation of NEET UG Exam Questions–2026 and that, in conspiracy with other accused persons, he had received the question papers and answers of NEET UG Exam, 2026 prior to the examination, i.e. on 23.04.2026. During the course of search conducted at the residence of the accused Sh. Shivraj Raghunath Motegoankar, in Sivaji Nagar, Latur on 14.05.2026, the leaked questions of the NEET UG 2026 were found in the mobile of accused Shivraj Raghunath Motegoankar. The said mobile was seized under the search list for forensic examination. In criminal conspiracy with the public servants associated with NTA. Investigation further disclosed that accused Sh. Shivraj Raghunath Motegoankar, in criminal conspiracy with other accused persons, provided copies of the leaked question papers and answer sheets to several persons, including Vivek Patil and others. Investigation has further revealed that accused Sh. Shivraj Raghunath Motegoankar has not disclosed the names of all the persons to whom he had supplied the hand written copies of the leaked NEET UG Exam, 2026 question papers. It has also emerged during investigation that the accused destroyed the leaked question papers after the examination and thereby caused destruction of evidence. That the aforesaid acts of the accused constitute cognizable offences punishable under Sections 61(2), 238, 303(2), 316(5), 318(4) of BNS, 2023, section 13(2) r/w 13(1)(a) of PC Act, 1988 (as amended in 2018) and section 10 r/w 3, 4, 5 & section 11 of The Public Examinations (Preventive of unfair means) Act, 2024.

In view of the above facts, there exist sufficient and reasonable grounds for your arrest.





REASONS OF ARREST

You are found directly involved in the commission of offences punishable Under sections 61(2), 238, 303(2), 316(5), 318(4) of BNS, 2023, section 13(2) r/w 13(1)(a) of PC Act, 1988 (as amended in 2018) and section 10 r/w 3, 4, 5 & section 11 of The Public Examinations (Preventive of unfair means) Act, 2024 in connection with case no. RC2212026E0010 dated 12.05.2026 registered at CBI, EO-III, New Delhi. Your arrest is deemed necessary (a) to prevent the commission of further offences, (b) to ensure a comprehensive and thorough investigation, (c) to prevent tampering with evidence, and (d) to preclude any possibility of influencing or intimidating witnesses as the reason for arrest (e) as you have not disclosed details of all the beneficiaries to whom you had provided the leaked paper and (f) as you have been found in destruction of incriminating evidences.


